# Company History

Bayer - Science for a better life.

Began in 1863 - Purple dye and the development of synthetics.

Created modern Aspirin in 1897

Began growing beyond pharmaceutical production in the 1990's with Polysar.

#### Purchased:

- Aventis crop science in 2001
- Monsanto in 2016

## Sales Data

2018 Annual report: Sales price of 39.6 Billion

Pharmaceutical sales were higher with lower earnings.

Consumer Health sales declined.

Share Earnings were up.

Crop Science sales were on the board for the first time.


# Bayer: strong operational start to the year

- // Pharmaceuticals shows encouraging sales and earnings growth
- // Consumer Health below the prior-year quarter; full-year outlook confirmed
- // Net income of €1.2 billion (-36.5%) held back as expected by special items related to the acquisition and restructuring

## Positioned for Growth

August 20, 2019 - Bayer to sell its Animal Health business

13 May 2019- Nivea Owner Buys Coppertone Sun Care for \$550 Million, "The German drug and chemical company has been wrestling with fallout from that deal, which has saddled it with more than 13,000 lawsuits related to its weedkiller Roundup."

22 July 2019 - Bayer to Sell Dr. Scholl's to Yellow Wood for \$585 Million

Third quarter of 2018- "Bayer has confirmed the outlook for the Group that was updated in the second quarter of 2018 to reflect the acquisition, while the forecasts for Consumer Health and Animal Health are now becoming increasingly ambitious."
